## Terms & Conditions

1. Every effort will be made to ensure exhibitors are placed on the Exhibitor Showcase floor where they will receive the most exposure for their product offering.
2. Exhibit spaces will not be assigned until after April 15, 2026 to pre-empt competing suppliers exhibiting in the same area.
3. The Exhibitor Registration may be cancelled by submitting the request in writing 30 days prior to the Summit. Cancelled registrations are subject to a cancellation fee of 50% of the exhibitor fee. No cancellations will be accepted, or refunds issued beyond this date. Equivalent substitution for representatives will be permitted and must accompany written notification to the FSAC office 2 weeks prior to the event.
4. The attendee list, owned by FSAC, will be distributed prior to the Summit and made available to all exhibitors. Attendee emails to be included in the distribution list only if permission is granted by the attendee. The attendee list is not to be distributed to any other party under any circumstance.
5. FSAC reserves the right at any time to alter or remove exhibits or any part thereof, including printed material, products, signs, lights or sound and to expel exhibitors or their personnel if, in FSAC's opinion, their conduct or presentation is objectionable to the FSAC or to other participants.
6. Aisles must be kept clear in the exhibit area.
7. Nailing, taping, stapling, and screwing into walls, ceilings, or floors or any other materials that would damage the property are strictly prohibited. Exhibitor floor space must be protected from any potential damage to flooring and all furnishings must be free-standing. Equipment with small gasoline engines must have fuel tanks drained and dry ice be placed in the empty gasoline tank. Should additional clean-up of the exhibit space be required post event, the exhibitor will assume the responsibility for payment of the associated fees.
8. Exhibit dismantling and move-out will be strictly prohibited until after the conclusion of the program and all visitors have vacated the exhibit area.
9. It is the responsibility of each exhibitor to comply with the laws, regulations imposed by the event venue with respect to fire, health and safety.



## Terms & Conditions Continued

10. FSAC shall not be liable for loss or damage of any article of equipment or property of an exhibitor that an individual may suffer during installation or removal or during the exhibit itself by reason of robbery, fire, accident, or any other destructive cause. The exhibitor, if desired, may obtain their own insurance.
11. Exhibitor agrees to indemnify and hold harmless FSAC, its officers, directors, members and employees from any and all liabilities, damages, losses, expenses or claims whatsoever arising from or connected with its display, any related materials, its conduct in the exhibit area, or any act or omission in contravention of applicable laws or industry guidelines, or any infringement of the rights of any third parties.
12. The following items are not included in exhibit booths: shipping and material handling, storage, power, audiovisual equipment rentals, carpet (the event space is fully carpeted), additional tables, wastebaskets, additional chairs, etc. These items may be ordered in advance. See page 9 for more details.
13. Supplier Spotlight: Time slots are filled on a first come, first served basis. All videos must be approved by the Summit committee prior to being confirmed. Presentations may be product specific. FSAC does not actively recruit participants for the spotlights.
14. Exhibitor booths must be CLOSED during all speaker sessions.
